Student worker hours were reduced due to the temporary relocation corresponding building renovation.

Screen Entry	The number entered (10,721) is outside the expected range of between 1,937 and 3,597 compared to the prior year value. Please correct your data or explain. (Error #15015)	Explanation	Yes	
Reason	A significant volume of microform books (over 7,000) were cataloged or otherwise made available in our discovery system.			
Screen Entry	The number entered (103) is outside the expected range of between 371 and 687 compared to the prior year value. Please correct your data or explain. (Error #15015)	Explanation	Yes	
Reason	Circulation was dramatically impacted by our temporary relocation of operations and remote storage of collection during a renovation of the library building.			
Screen Entry	The number entered (1,316) is outside the expected range of between 109 and 201 compared to the prior year value. Please correct your data or explain. (Error #15015)	Explanation	Yes	
Reason	In previous years, only serials from a single collection were counted. This time we counted serials from all collections.			
Screen Entry	The Librarians(4.00) is outside the expected range compared to Librarians reported in the prior year(5.75). Please correct your data or explain. (Error #15812)	Explanation	Yes	
Reason	Previous years classified some library staff as librarians; according to the definitions provided for the survey, we adjusted this to be more accurate. Moreover, the position listed as .75 is effectively 1 FTE. Previous years this was counted as less than 1 because a portion of the salary and job duties are related to a grant. However, review of the definitions provided with the survey make it clear that this grant funding aspect should be counted.			
Screen Entry	The Student Assistants(1.00) is outside the expected range compared to Student Assistants reported in the prior year(2.00). Please correct your data or explain. (Error #15815)	Explanation	Yes	
Reason	The amount of hours our student workers could work was dramatically impacted by our library building's renovation; we operated from a temporary location, and the collection was only accessible by staff in a remote location.
