## **Instructions for Providing Tax Documentation**

Link to IRS using the IRS Data Retrieval Tool on the FAFSA:

- 1. Go to www.FAFSA.gov
- 2. Log in to your 2020-21 FAFSA
- 3. Select "Make FAFSA Corrections"
- 4. Navigate to the Financial Information section (for both the student and parent, if applicable)
- 5. Answer a few questions and then click "Link to IRS" to transfer 2018 IRS income tax information into your FAFSA
- 6. Successfully transferring your tax information using the IRS Data Retrieval Tool returns you to your FAFSA
- 7. You must re-sign the FAFSA and submit the updated information.

**Please Note:** If you are providing a copy of a 2018 Federal Tax Return it must be **signed**. If you filed an amended return in 2018, you will also need to submit a **signed** copy of your IRS Form 1040X.

### If you are unable to use the Link to IRS

Some students and parents may be unable to use the IRS Data Retrieval Tool. Examples of these situations include, but are not limited to:

- Marital status change after December 31, 2018, or
- > Tax filing status of "married filing separately" and marital status of "married/re-married" when completing the FAFSA, or
- You filed a foreign tax return.

If you are unable to use the IRS Data Retrieval Tool, you can contact the IRS directly for the below items (if needed):

- 2018 IRS Tax Return Transcript
  - If you filed an amended return in 2018, you will also need to submit a signed copy of your IRS Form 1040X.
- 2018 Wage and Income Transcript
- 2018 IRS Verification of Non-filing Letter (dated 10/1/19 or after)

### Choose **one** of the following options:

- Go to http://www.irs.gov/transcript
  - Click "Get Transcript ONLINE" to register, then print or download your transcript immediately.
  - O Click "Get Transcript by MAIL" to receive your transcript in 5 to 10 calendar days.
- Call 1-800-908-9946 to order a transcript to be mailed to you.
- Submit a Form 4506-T, Request for Transcript of Tax Return, to the IRS via fax or mail to order a transcript to be mailed to you.
- You may be able to go directly to your local IRS office for an in-person request. You will have to call
